[This was the most successful period in the recent history of the Department. The following were some of the Department’s main achievements during it: (1) Faculty recruitment – the Department added at the senior level James Conant, John Haugeland, David Finkelstein, Michael Kremer, and Charles Larmore, and at the junior level Rachel Barney, Michael Green, Jason Bridges, Jonathan Beere, and Gabriel Lear. (2) Successful integration into the Department of three eminent faculty members who were initially appointed to other units – Jonathan Lear, Martha Nussbaum, and Robert Pippin. (3) Admission, recruitment, and funding of graduate students – the applicant pool improved greatly in both size and quality during this period, as did the acceptance rate, as did the level of funding we were able to offer students (reaching the present state of affairs in which all graduate students admitted receive full tuition plus a generous stipend for 5 years). (4) Graduate

student placement – during this period the Department was regularly ranked first among all philosophy departments in the USA by the *Lingua Franca* survey of graduate placement, many of our students securing tenure-track positions in top departments such as Yale and Princeton. (5) Office improvements – during this period the Department negotiated and then began a major relocation from scattered quarters in the Classics Building and other parts of the University to its present unified and in other respects improved quarters in the Stuart Building. (6) Cooperation with the Human Rights Program at The University of Chicago – this period saw the development of much closer cooperation between the Philosophy Department and the Human Rights Program, including joint hiring.]

Summary Report (2013–20) (submitted to the Humboldt Foundation on 25/4/21)

The following points summarize some of the most significant results of my Humboldt-Professorship during the prize-period 2013–20.

The Philosophy Department

My original nomination by Bonn University for a Humboldt Professorship envisaged not only my integration into the Philosophy Department but also the Department's further expansion and internationalization. In these respects my Humboldt Professorship has gone very well.

I have worked especially closely on international projects with the following colleagues from the Department: Markus Gabriel (e.g., in the International Summer School for German Philosophy that we have organized and taught together almost every year since 2014), Christoph Horn (e.g., in an international conference on "Nietzsche and the Greeks" that he and I co-organized in 2016 at the Nietzsche-Dokumentationszentrum in Naumburg and in a German-French Reading Group that I have organized since 2015 in which he sometimes participates), Dieter Sturma (e.g., in an international conference on "Alexander von Humboldt in Context" that we co-organized in 2019 at Bonn University), and Rainer Schaefer (e.g., in a Humboldt-Kolleg on "The Idea of an Idea" that I co-organized with a Turkish colleague at Istanbul University and in which he actively participated, as well as in regular seminars on Hegel's *Phenomenology of Spirit* that he and I have given together at Bonn University).

In addition, during my Humboldt-Professorship the Philosophy Department has succeeded in attracting several new professors both from Germany and from overseas, so that the hope originally invested in my nomination that it would lead to further development of the Department, especially through an increase in researchers with an international profile, has not been disappointed: Aimee van Wynsberghe (Alexander von Humboldt Professor for artificial intelligence, who came from Holland), Wouter Goris (Chair for Medieval Philosophy, who likewise came from Holland), Dennis Lehmkuhl (Lichtenberg Professor for History and Philosophy of Physics, who came from the USA), Rainer Schaefer (W-2 Professor for Classical German Philosophy), Burt Heinrichs, and Annette Dufner (both W-2 professors for practical philosophy).

My Humboldt-Professorship in particular made it possible for me to negotiate and fund the appointment to a W-2 professorship of Rainer Schaefer, who is an outstanding expert on classical German philosophy, has since been tenured, and now serves as departmental chairman.

A similar point applies to Lina Steiner, who is now a tenured Senior Lecturer (akademische Rätin) on my professorial chair and Director of the Research Center for Philosophy and Literature. Thanks to my Humboldt-Professorship, I was able to win her from The University of Chicago, where she was already Associate Professor, for Bonn University in 2013. She is a specialist for both Comparative Literature and Slavic Studies, and is in particular one of the world's leading experts on Russian literature.

Additional Contributions to the Improvement of Bonn University

Since 2013 I have directed the International Center for Philosophy North Rhine Westphalia together with Markus Gabriel and am also a founding member of the Center for Science and Thought, which he directs. Both Centers have been quite successful.

The two appointees just mentioned above, Schaefer and Steiner, both play a vital role in the International Center. During my Humboldt-Professorship I was also able to appoint the following junior faculty members (*wissenschaftliche Mitarbeiter*) in the Center using a combination of resources from the Humboldt-Professorship and from the University: Dr. Guido Kreis, Dr. Enrico Mueller, Dr. Stephan Zimmermann, Dr. Mattia Riccardi, Dr. François Thomas, Dr. Dorothee Schmitt, and Dr. Laure Cahan-Maurel. Several of these junior faculty members have since gone on to very good positions at other universities: Kreis to a professorial chair of his own at Aarhus University in Denmark, Riccardi to an Associate Professorship at the University of Porto in Portugal (which is where his wife comes from), Thomas to a position as Senior Lecturer (Maître de Conférences) at the University of Paris, Nanterre (where he also now serves as Chair of the Philosophy Department). These people not only made an outstanding contribution to teaching and the organization of conferences at the University, but have also distinguished themselves with many excellent publications, e.g., Schaefer with his monograph on Hölderlin *Aus der Erstarrung* (Meiner Verlag, 2020); Steiner with her (co-)edited volumes *Romanticism, Philosophy, and Literature* (Palgrave-Macmillan, 2018) and *The Palgrave Handbook of Russian Thought* (Palgrave-Macmillan, 2021) as well as scholarly articles in those volumes and elsewhere; Kreis with his books *Negative Dialektik des Unendlichen* (Suhrkamp, 2015) and *Gottes-Widerlegungen* (Suhrkamp, 2022); Mueller with his *Nietzsche-Lexikon* (UTB, 2020); and Riccardi with his book *Nietzsche's Philosophical Psychology* (Oxford University Press, 2021). In addition, Schmitt is in negotiations with Oxford University Press about writing a book on relativism in English.

Concerning doctoral students, I have been able to do several things since 2013: 1. I have acted as supervisor for about a dozen doctoral dissertations, of which 6 have now been successfully defended (Melanie Riedel [on Simmel], Simon Waskow [on Hegel], Sophia Fazio [on Kant], Céline Krestel [on Shaftesbury], Jan Paffrath [on Marx], and Florian Maiwald [on J.S. Mill]), another 1 has already been submitted (Mariana Dimopulos [on philosophy of translation]), and several more have dissertation projects well underway (including Herr Kang [on Nietzsche], Kimsoo Park [on Kant], Bo Tang [on German Romanticism / Heidegger], Diego Rodriguez [on Herder], and Sam Müller [on *Bildung*]). 2. I have also served as a co-advisor and/or examiner for many of my colleagues' doctoral candidates, especially Markus Gabriel's. 3. I have also been able to employ a number of doctoral candidates as assistants (*wissenschaftliche Hilfskräfte*), charged mainly with helping to organize conferences and edit publications (Jaroslaw Bledowski, Eva Jeske, Jan Paffrath, Melanie Riedel, Simon Waskow, Levin Zende, and Florian Maiwald). 4. I was also able to organize an exchange program for doctoral students between The University of Chicago and Bonn University that I funded with resources from my Humboldt-Professorship. This exchange program lasted for 5 years and allowed an average of 2 students per year to spend a year at the other university (in total, 9 students benefited from this opportunity, drawn in roughly equal measures from the two universities, of whom several have now completed their doctorates and gone on to academic positions). 5. Almost every year since arriving in Bonn (with exceptions due to Corona) I have organized, funded, and taught, together with my colleague Markus Gabriel, an International Summer School for German Philosophy which brings about 35 carefully selected doctoral students from all over the world to Bonn for a two-week course each year. My Humboldt funding allowed me to provide stipends for about 12 of the most talented and financially underprivileged of these participants each year, to invite several internationally renowned speakers to give talks in the Summer School each year, and to hold at least one collective dinner for all participants/speakers each year.

The International Center for Philosophy NRW and the Internationalization of Philosophy at Bonn University

Since arriving at Bonn University in 2013 I directed the International Center for Philosophy NRW together with Markus Gabriel. The International Center was already founded before my arrival by Wolfram Högbe and then developed by Markus Gabriel. Since 2013 we were able to develop it even further, largely thanks to the funding provided by my Humboldt-Professorship.

My own approach – which would not have been possible without the Humboldt Foundation’s generous funding – has been to make philosophizing in the International Center genuinely international in the sense that not only the participants but also the philosophical ideas considered are drawn from a variety of different countries and traditions around the world. (This approach is connected with two of my own philosophical positions: a general anti-universalism and a form of moral cosmopolitanism that I call “pluralist cosmopolitanism.”) Such an approach is extremely ambitious and could easily become impossibly so. I have therefore made it a bit more manageable by concentrating on the five main living traditions in philosophy: the German, Anglophone, French, Chinese, and Russian traditions.

Concerning German philosophy (which is my own academic specialty), the funding associated with my Humboldt-Professorship has enabled me to (co-)organize many international events in the International Center largely focused on German philosophy: international conferences, individual lectures and seminars by eminent guests, the International Summer School for German Philosophy, the German-French Reading Group, etc. I have also been able to (co-)organize many international events at other universities/centers in Germany, e.g., at Jena University (in particular, an international conference on German Idealism and German Romanticism that I organized there with Klaus Vieweg), LMU in Munich (in particular, an international conference on “humanity” in the eighteenth century that I organized there with Stefanie Buchenau and Ansgar Lyssy), and the Nietzsche-Dokumentationszentrum in Naumburg (a conference on “Nietzsche and the Greeks” that I organized there with Christoph Horn). In addition, many of the events that I have been able to organize with Anglophone colleagues and shall describe in the next paragraph have focus on German philosophy. Several volumes based on papers from these various events have already appeared, e.g., in connection with conferences held in Bonn *The Cambridge Companion to Hermeneutics* (Cambridge University Press, 2019) and *Romanticism, Philosophy, and Literature* (Palgrave-Macmillan, 2020), and in connection with the conference in Jena *Idealismus und Romantik in Jena* (Fink, 2018). Further volumes are currently in preparation as well, e.g., volumes for the conferences at LMU and at the Nietzsche-Dokumentationszentrum. In addition, again with the help of the financial support provided by my Humboldt-Professorship, I was able to co-edit with Kristin Gjesdal an ambitious volume on nineteenth-century German philosophy that includes contributions from both German and Anglophone scholars: *The Oxford Handbook of German Philosophy in the Nineteenth Century* (Oxford University Press, 2015).

Concerning the Anglophone world, thanks to the resources of my Humboldt-Professorship, I was able in 2014, in close co-operation with colleagues from the Philosophy Department at NYU (Paul Boghossian, Anthony Appiah, and Jeremy Waldron), to invite the Global Citizenship Commission of the United Nations under the leadership of the former British prime minister Gordon Brown to Bonn University, where the Commission not only worked on improvements of the International Declaration of Human Rights for the United Nations (the Commission’s proposals have since been published in book form) but also gave several public presentations on the subject of human rights (one of them a collective “public facing” session, two others individual lectures). In 2015 I was able, thanks to funding from my Humboldt-Professorship, to found a new International Society of Nietzsche Studies together with Brian Leiter (The University of Chicago), Ken Gemes (Birkbeck College, University of London), and other eminent

Anglophone Nietzsche scholars, as well as to organize its inaugural conference in the International Center. The contributions to this conference were then published in a special edition of the respected journal *Inquiry* in 2017. In addition, since 2014 I have co-taught a seminar with Brian Leiter in the Law School at The University of Chicago each February/early March for students from both law and philosophy (mostly on topics in German philosophy). On these occasions in Chicago I have also with the help of my Humboldt funding been able to organize conferences on aspects of German philosophy in cooperation with Brian Leiter and other colleagues from The University of Chicago, especially Françoise Meltzer and Thomas Pavel. The topics of these conferences have included Nietzsche, Marx, German Romanticism, and A.W. Schlegel. I have also been able with the help of my Humboldt funding to (co-)organize conferences at several other American and Canadian universities, including a series of workshops on the history of logic at McMasters University in Canada (in cooperation with Sandra Lapointe; other participants in these workshops included Frederick Beiser, Nicholas Griffin, Jeremy Heis, Nick Stang, Graham Priest, and Clinton Tolley) and a conference on Spinoza's hermeneutics and political philosophy at the Johns Hopkins University in 2020 (co-organized with Jason Jonover and Yitzhak Melamed; other participants were Frederick Beiser, Martin Bollacher, Eckart Förster, Sebastian Gardner, Kristin Gjesdal, Micah Gottlieb, Zev Harvey, Johathan Israel, Tracey Matysik, Dean Moyer, and Michael Rosenthal). In addition, thanks to my Humboldt funding, I have been able, together with Markus Gabriel, to invite several eminent analytic philosophers from the Anglophone world to Bonn to give talks/seminars (including Ned Block, Robert Brandom, and Tyler Burge). Now that the period of the Humboldt funding has ended, I have continued organizing such events in the Anglophone world. For example, I am currently co-organizing with Susan Hahn a conference "Kant, Hegel, and their Successors," which will take place at Harvard University in November, 2025.

Concerning France, since 2015 I have been able, thanks to my Humboldt funding, to organize, together with François Thomas and Christian Berner (both now at the University of Paris Nanterre), a German-French Reading Group that meets about four times each year, alternating between Bonn and Paris. This reading group selects German and French philosophical texts of common interest to the group and discusses them for several hours each session under the guidance of a presenter (authors have included the German Romantics in general, Schleiermacher in particular, Marx, Nietzsche, Montaigne, Rousseau, and Bergson). Over the years the activities of the reading group have expanded to also include conferences and workshops, whose topics have included cosmopolitanism in the Enlightenment, the concept of a "stranger," and the translation of poetry. Besides Christian Berner, François Thomas and myself, other regular participants in the reading group and its related events include Lina Steiner, Simon Waskow, Andrea Wilke, Levin Zende, Jan Paffrath, Laure Cahan-Maurel, and Jens Rometsch (all from Bonn University), Matthieu Amat (University of Lausanne), Stefanie Buchenau (University of Paris 8), Marc de Launay (ENS/CNRS), Charlotte Morel (ENS/CNRS), and Françoise Rétif (University of Rouen). I was also able to co-organize a conference on empathy with Thomas Pavel at the Paris Center of The University of Chicago during a year in which he was serving as Director there. In addition, I have regularly participated in, and presented papers at, other conferences in France (e.g., at the École normale supérieure, Poitiers University, and the Sorbonne). I have also written evaluations, and served on commissions, for several younger colleagues in France, including Lucas Pétauud-Létang (doctoral dissertation, Bordeaux), Stefanie Buchenau (Habilitation, Sorbonne), and François Thomas (doctoral dissertation, Lille). Finally, since 2013 I have also served as a member of the governing board of the Institut français in Bonn, with which I have organized several joint events, including public lectures for "Ringvorlesungen" by eminent philosophers and literary scholars (Helmut Hühn, Jean-François Kervégan, and Thomas Pavel).

Concerning China, since 2014 I have been able, with the help of my Humboldt funding, to organize a series of conferences at Bonn University and several other universities in Europe and

China on the relation between Western and Chinese philosophy in co-operation with both German and Chinese colleagues – in particular, Guido Kreis (Aarhus University), Kai Marchal (National Chengchi University, Taiwan), Tze-wan Kwan (Chinese University of Hong Kong), and Chung-ying Cheng (University of Hawaii). I have also since 2014 taught as a guest professor for short periods at two Chinese universities (at Renmin University in Beijing in the context of a summer school on philosophy and anthropology organized by King's College, London in 2017; and at Huaqiao University in Xiamen on the subject of the German Romantics' philosophy of language in 2019). In addition, I co-edited with Guido Kreis two volumes of *The Journal of Chinese Philosophy* in 2017 containing papers from the aforementioned conferences (including one of my own). More recently, the editor of *The Journal of Chinese Philosophy*, Chung-ying Cheng, invited Guido Kreis, Tze-wan Kwan, and myself to edit three further volumes of the Journal to celebrate the fiftieth anniversary of its founding: two volumes on practical philosophy, one volume on the philosophy of translation (volumes for which I again contributed articles). These volumes appeared in 2022/3. In addition, a book based on another of the aforementioned conferences (held at National Chengchi University in 2019 on the aesthetics of Chinese landscape painting) is currently being edited by Guido Kreis and Kai Marchal (to which I have again contributed an article). These links with China are continuing now that the period of my Humboldt funding has ended. For example, in 2025 I shall hold the Tang Chun-I Visiting Professorship at The Chinese University of Hong Kong in September, giving several seminars and public lectures, as well as attending the conference "China and World Philosophies" at Xidian University in October, where I will give a talk on views about contradiction in the West and the East.

Concerning Russia, in 2017, thanks to my Humboldt funding, together with invaluable support from Dr. Steffen Mehlich of the Humboldt Foundation and his wife Professor Julia Mehlich (Lomonosov University), I was able, in cooperation with Lina Steiner (who is Russian by birth and an expert in Slavic Studies) and Marina Bykova (who is likewise Russian by birth and an expert on Russian philosophy), to organize the conference "Russian Thinkers: Between the Revolution and Tradition" at Bonn University. This conference led to Bykova, Steiner, and myself editing not only two volumes of the journal *Studies in East European Thought* (2018/9) but also *The Palgrave Handbook of Russian Thought* (Palgrave-Macmillan, 2021), an ambitious volume that contains 36 chapters covering virtually the whole Russian philosophical and literary tradition. In addition (again thanks to the Mehlichs), I have had the opportunity to visit Moscow on two occasions to participate in a conference and a Humboldt-Kolleg there, in the course of which visits I gave several talks at the Lomonosov University and the Russian Academy of the Sciences. (It is to be hoped that after the terrible war in Ukraine that is currently going on it will be possible to resume this cultural exchange.)

These projects connected with Germany, the Anglophone world, France, China, and Russia constitute a new model for international philosophizing. They have already generated important new research and continue to do so; they have made a modest but significant contribution to strengthening the cultural ties between countries; and they have also added to the international profile of both the Humboldt Foundation and Bonn University.

In addition, since 2013 I have had the honor and the intellectual benefit of participating in, and presenting papers at, several international Humboldt-Kollegs (conferences) held in various countries on a wide range of subjects. These took place in Amsterdam, Bonn (twice), Istanbul, Jerusalem, and Moscow. Like many of the conferences mentioned above, these Kollegs were not only international but also interdisciplinary (for example, the topic of the one in Jerusalem was the human sciences in the nineteenth century).

Interdisciplinarity at Bonn University

My original nomination by Bonn University for a Humboldt Professorship was also connected with a hope that I would make a contribution to interdisciplinarity at the University. I have attempted to fulfill this expectation as well.

I have now taught for 40 years at The University of Chicago (until 2013 as Glen A. Lloyd Distinguished Service Professor, since 2013 as guest professor), which is justly considered one of the foremost universities for interdisciplinary research in the world; I am a specialist on one of the most important interdisciplinary thinkers in the history of philosophy, Johann Gottfried Herder; and I myself research in an interdisciplinary spirit (e.g., my recent book *Herder's Philosophy* (Oxford University Press, 2018) contains chapters not only on more standard philosophical topics, but also on hermeneutics, translation theory, linguistics, and cultural anthropology).

Accordingly, I have conceived the aforementioned international projects in an interdisciplinary spirit as well. A few examples of this: Among the colleagues with whom I have worked most closely on them, Lina Steiner comes from Comparative Literature and Slavic Studies, while Kai Marchal is primarily a sinologist. The volume *Romanticism, Philosophy, and Literature* and the conference in Bonn on which it was based included not only philosophers but also literary scholars and musicologists. The volume *The Cambridge Companion to Hermeneutics* and the conference in Bonn from which it emerged included contributions not only from philosophy, but also from sinology, legal scholarship, political science, history, literary studies, and theology. *The Palgrave Handbook of Russian Thought* and the conference in Bonn out of which it grew included specialists not only from philosophy, but also from history, political science, literary studies, philology, Slavic studies, musicology, and other disciplines.

Since arriving in Bonn in 2013 I have also been able to support several other interdisciplinary projects at the University. For example, I am a founding member of Markus Gabriel's Center for Science and Thought, which brings together philosophy and the natural sciences; I played a part in the official visitation of Bonn University that led to its selection as an Exzellenzuniversität in 2019 with a special eye to its inter- or trans-disciplinary research; I contributed an article (on "Critique") to the ambitious *Bonner Enzyklopädie der Globalität / Bonn Handbook of Globality*, edited by two colleagues from Bonn University, Ludger Kühnhardt and Tilman Mayer; and I gave a talk at an "Interdisciplinary Research Conference" that was organized by the whole philosophical faculty in 2019.

My own research and publications

My own research and publications have naturally been a central part of my Humboldt Professorship as well.

My main book publication since 2013 was *Herder's Philosophy* (Oxford University Press, 2018). This volume is the culmination of many years of research devoted to Herder's philosophy, its influence, and its importance (my earlier contributions include many scholarly articles on Herder in journals and collected volumes, the book *Herder: Philosophical Writings* (Cambridge University Press, 2002), which has become the main source for Herder's philosophical writings in the Anglophone world, and the two connected monographs *After Herder* (Oxford University Press, 2010) and *German Philosophy of Language* (Oxford University Press, 2011)). *Herder's Philosophy* presents an overview of Herder's philosophical achievements (including his virtual establishment of modern philosophy of language, hermeneutics, translation theory, linguistics, and cultural anthropology), his great influence on subsequent thinkers (right down to our own times), and his enduring philosophical importance, e.g., the way in which his ideas are often in important respects actually better than their descendants in his later followers.

My main current book project in 2025 is *Friedrich Schlegel's Philosophy* (again for Oxford University Press), which includes sections on his metaphysics/epistemology, his philosophy of language (including hermeneutics, linguistics, translation theory, and philosophy of philology), his philosophy of literature and art, his political philosophy, and his contributions to the historiography of philosophy. I have now completed a full draft of this book and expect to submit it at the end of 2025.

Since 2013 I have also co-edited several collected volumes and published many articles in collected volumes and journals on a wide range of topics (please see the above CV). In addition, since 2013 I have given many public lectures/talks at universities and other venues around the world (please again see the above CV).
